

## **KEYNOTE 1**



## Improving infectious and non-infectious disease outbreak prevention, detection and response for sustainable UHC

### Keynote 1 Objectives

Strengthening surveillance and early detection of infectious disease outbreaks has seen progress through the utilization of digital health tools, facilitating timely identification. Additionally, disease prevention and health promotion strategies are central to achieving sustainable Universal Health Coverage (UHC), exemplified by vaccination programs, public health campaigns, and lifestyle interventions aimed at reducing the incidence of both infectious and non-infectious diseases. Collaboration on outbreak prevention and response is emphasized, with international organizations, public-private partnerships, and regional initiatives playing a pivotal role in coordinating efforts within Tanzania. Moreover, building robust and rapid response capabilities, informed by cross-sectoral collaboration and timely resource mobilization, remains crucial to minimize the impact of disease outbreaks on health systems and communities. The concerning rise of non-communicable diseases in Tanzania is attributed to lifestyle choices, climate change, and air pollution, collectively contributing to this emerging "pandemic" that requires comprehensive public health strategies to mitigate its effects and advance UHC goals.

## The challenges and opportunities of achieving UHC in the ever changing population dynamics

## Key note 2 Objectives

In Tanzania, population dynamics, including migration, urbanization, and an aging population, profoundly influence healthcare and Universal Health Coverage (UHC). These shifts demand tailored strategies to accommodate diverse populations, considering cultural complexities, gender dynamics, and equitable access to healthcare. National plans should prioritize addressing the unique needs of minorities, migrants, and remote communities while emphasizing cultural competence and gender equity. The rising burden of Non-Communicable Diseases (NCDs) alongside infectious diseases underscores the need for comprehensive strategies encompassing NCD prevention, management, and control. Primary healthcare services must be equipped to handle NCDs, while health promotion and lifestyle interventions are essential to mitigate their prevalence. To maintain progress towards UHC, Tanzania must strengthen health financing through sustainable models, efficient risk pooling mechanisms, and strategic resource allocation that adapts to changing demographic needs while ensuring healthcare access for all.

# The Rationale of Integrating of Quality improvement in Universal Health Coverage Rollout – The Private Health Sector Perspective

## Aim of the Forum

The aim of this forum is to shed light on the imperative need for the integration of quality improvement initiatives within the framework of Universal Health Coverage (UHC) rollout, with a specific focus on the perspective of the Private Health Sector. As the healthcare landscape evolves globally, ensuring access to healthcare services for all remains a paramount goal. However, the mere expansion of healthcare coverage without a concurrent commitment to enhancing the quality of care can lead to suboptimal health outcomes.

## Adolescent Mental Health and Nutrition in Tanzania: Evidence, Policy, and Practice

## Aim of the Forum

Adolescence (10-19 years) significantly shapes an individuals lifelong health trajectory. In Tanzania, this group faces a number of health related challenges. The 2014 Tanzania Mainland Global School-based Student Health Survey highlighted prevalent mental health issues, including loneliness/depression and suicidal behavior (MoHCDGEC 2017). Undernutrition and stunting are also prominent, with higher rural burdens and variations by gender and regions.

AAPH is committed to advancing innovative research and capacity building, aiming to address the pressing health challenges faced by adolescents. This panel aims to view and understand the policies and practices on adolescents' mental health and nutrition in Tanzania, and to strengthen the network and collaboration among the stakeholders involved in this field. 

## Aim of the Forum

Despite progress, Tanzania still faces persistent challenges in achieving Universal Healthcare Coverage (UHC), including limited healthcare financing and inequitable access to quality care. Around 70% of Tanzanians lack health insurance, while inadequate infrastructure and workforce shortages exacerbate the problems. However, the widespread adoption of mobile and digital innovations in the country are now transforming how healthcare is being financed and delivered.

Tanzania has been a pioneer in digitizing its health management system since 1990 and was one of Africa's first to launch a National eHealth Strategy in 2013. Innovative digital and data-driven tools are now connecting payers, providers and patients, to improve efficiency, reduce costs and improve quality of services. Real-time data is informing decision makers, while digital care models are reaching and empowering previously excluded individuals. ## Sustainably Financing Tanzania's Health Sector on the Path to UHC

The government of Tanzania (GoT) is committed to making progress towards universal health coverage (UHC). According to the 2019/20 National Health Accounts, the government funds approximately 22% of the health sector and is dependent on development partners (34%) and out-of-pocket payments (32%). A growing percentage is also coming from insurance premiums (12%). Tanzania is working towards developing a more sustainable national health sector response to reach country goals through increased domestic resource mobilization, improved public financial management and consideration of Universal Health Insurance. Village Savings and Loan Associations (VSLAs) Driving Universal Health Coverage in Tanzania: Opportunities and Path Forward

## Aim of the Forum

Village Savings and Loan Associations (VSLAs) empower Tanzanian women by pooling savings and offering loans. CARE Tanzania has facilitated 30,402 VSLA groups with 718,726 members, primarily women. These groups have collectively saved TZS 64,179,545,925. A study involving 533 VSLA members from five Tanzanian regions found that 60% sought financial aid for health services, with 81% obtaining support from VSLAs. However, only 10% had health insurance.

Therefore, this forum aims to address the importance of leveraging VSLAs in advancing healthcare access and improving community health. By harnessing the potential of VSLAs and promoting health insurance coverage within these groups, Tanzania can make substantial strides towards achieving universal health coverage and elevating overall community wellbeing.

## Successful engagement of community structures in public health emergency response

## Aim of the Forum

The Ministry of Health (MoH) in Tanzania has been implementing IDSR framework since 1997 in all regions as a requirement for IHR. Amref Health Africa Tanzania funded through US. CDC collaborates with the MoH and PORALG to strengthen the Surveillance system in Tanzania. Amref pioneered the establishment of Community Based Disease Surveillance (CBDS) in 2009 bridging the informal and formal health systems using trained CHWs. Lessons learnt were used to roll out Community-Based Surveillance (CBS) in Arusha and Kilimanjaro in 2015.

A scale-up of CBS to Kagera and Kigoma paved the way for the Event-Based Surveillance (EBS) in 2018. To date, Amref has rolled out EBS in eight high-risk regions working with over 1,400 CHWs who detect and report alerts to the formal health system for response. In 2020, MoH developed and piloted an electronic EBS system in the Arusha and Kagera regions blended with strengthening alert desks at regional level. Today's forum, intends to share with you the successful engagement of community structures in public health emergency response.

Collaboration across ministries for successful innovation adoption and system change; The M-mama emergency transport system as a case study.

### Aim of the **Forum**

Small-scale health innovations often display promising results but struggle to sustain or expand beyond initial target areas (ExpandNet WHO). In contrast, the M-mama emergency transport system defies this trend. Originating as a pilot initiative in Shinyanga from 2013 to 2021, it has now successfully transitioned to a nationwide scale across Tanzania Mainland and Zanzibar.

The aim of the M-mama system is to curtail maternal and neonatal morbidity and mortality by strengthening health systems and leveraging innovative mobile and digital technology to facilitate timely access to emergency transportation for expectant mothers and neonates. The program implementors will use the M-mama system as a case study to share their experience in structuring a project and successfully translating it into a national system, which resulted to an estimated 1000 lives saved.

As the leading cause of cancer-related deaths among women in East Africa, cervical cancer is of paramount concern. # Why Access to Clean Water and Sanitation (WASH) is a Vital Subject in Universal Health Coverage (UHC)

# Aim of the Forum

Despite the establishment of guidelines and persistent efforts by the Ministry of Health (MoH) and its partners, a noticeable gap in water, sanitation, and hygiene (WASH) still exists within healthcare facilities (HCFs) in Tanzania. Research indicates that nearly half of these facilities lack access to piped water. The objectives of this session are twofold: firstly, to emphasize the pivotal role that WASH plays in advancing equitable access and improving health outcomes within healthcare facilities.

Secondly, to identify specific interventions and opportunities to seamlessly integrate WASH practices into public health programs within the health sector. The desired outcome is to gather perspectives on the importance of WASH concerning UHC and provide policy and decision-makers with actionable recommendations for enhanced healthcare delivery.

# The "pandemic" of Non-Communicable Diseases in Tanzania and SSA

# Aim of the Forum

Sub-Saharan Africa, particularly East African countries, is experiencing a significant surge in non-communicable diseases (NCDs) in the last two decades. These encompass a wide range of conditions, from diabetes, cardiovascular diseases and others, affecting individuals across all age groups. Recent research conducted by the NIMR revealed factors like early-life malnutrition, climate change, air pollution, and biodiversity loss are among the emerging contributors to this growing health crisis.

To address these challenges effectively, there is an urgent need for innovative solutions and international collaboration. These solutions should encompass population-level NCDs screening in primary care settings, early diagnosis to prevent complications, improved access to essential medications, and the comprehensive training and education of both medical and non-medical specialists. These efforts are essential to mitigate the expanding NCD crisis.

## Economic Empowerment Initiatives Compliments HIV Prevention Efforts among Vulnerable Adolescent and Young Women

# Aim of the Forum

Adolescent girls and young women (AGYW) face a heightened vulnerability to HIV acquisition compared to boys. The susceptibility to HIV infection is contributed by socio-economic and cultural factors such as power dynamics, inability to negotiate condom use, and economic vulnerability. To end new infections among the growing population of adolescents in the country, HIV prevention programs must address the gender and economic inequalities driving excessive risk among adolescent girls more effectively.

The USAID-funded, EpiC project economically empowers AGYW in 11 regions of Tanzania to overcome HIV risk, alongside the provision of behavioral and biomedical services. In this forum, EpiC will showcase the importance of economic empowerment initiatives in complimenting HIV Prevention and treatment efforts among vulnerable AGYW. It will emphasize how closing the HIV transmission gap among AGYW cannot be achieved only by behavioral and clinical (biomedical) interventions; hence the economic empowerment initiative is of equal importance.

This forum will be an opportunity to highlight the vision for the establishment of an NPHI in Tanzania with contributions from a number of key stakeholders.

# Women Lead Climate Resilience: Building health and climate resilience through integrated programming

# Aim of the Forum

Pathfinder, in collaboration with its partners, has been at the forefront of innovation over the past decade, focusing on strengthening health and climate resilience through integrated population, health, and environment (PHE) programming. Their PHE model effectively combines sexual reproductive health with conservation efforts to achieve positive outcomes for both communities and the delicate ecosystems essential for their survival and livelihoods.

In this symposium, Pathfinder and The Nature Conservancy (TNC) will share the successes and learnings from over a decade of integrated programing in the Greater Mahale Ecosystem in Western Tanzania, the Northern Tanzania Rangelands. 
